Hello Fantastic Sams stylists!

We look forward to face-to-face trainings with you beginning in July. Until further notice, we will implement the following procedures for everyone's benefit:

- Online registration is suspended. Attendees must sign up for class by calling their educator.
- Trainings are limited to 10 attendees per class. Students are required to practice social distancing.
- We will instruct you to wear a mask anytime you leave the designated classroom area where you can come in contact with office or premises personnel (this includes entering and exiting the building, using the bathroom, etc.)
- We will practice sanitation and sterilization guidelines as mandated by the DBPR in all areas we occupy, including frequent washing of hands.
- We ask you not to share pencils, pens, class handouts or any tools with fellow students.
- We will ask all attendees specific questions. If you answer "yes" to any of them, you will be dismissed and asked to attend training at a later date. The questions are:
  - Have you or anyone in your household or workplace had any of the following symptoms in the last 14 days: sore throat, cough, chills, body aches for unknown reasons, shortness of breath for unknown reasons, loss of smell, loss of taste, fever at or greater than 100 degrees Fahrenheit?
  - Have you or anyone in your household visited or received treatment in a hospital, nursing home, long-term care, or other health care facility in the past 14 days?
  - Have you or anyone in your household traveled in the U.S. in the past 14 days?
  - Have you or anyone in your household traveled on a cruise ship in the last 14 days?
  - Do you have any reason to believe you or anyone in your household has been exposed to or acquired COVID-19?
  - To the best of your knowledge have you been in close proximity to any individual who tested positive for COVID-19?

Protocol for sanitation is as follows: Before each class, all surfaces prone to cross contamination will be sprayed with an EPA registered hospital grade disinfectant, then wiped down according to directions. These areas include chairs, table and counter tops, doorknobs, bathroom surfaces and any other surface attendees come in contact with. We will provide the disinfectant and keep it on hand at all times. Directions state to spray all surfaces and implements, let sit for a period of 10 minutes then wipe thoroughly with a clean cloth. These areas will be treated again prior to leaving for lunch breaks and at the end of the day.
